This report includes the pardon and reprieve certificates, and the application forms submitted for each pardon.

My constitutional authority to grant clemency in criminal cases in the form of pardons, commutations of sentence, and reprieves is an important part of California's criminal justice system that can promote accountability, rehabilitation, public safety, make jails and prisons safer, and correct unjust results in the legal system.

Jamar Baines

Jamar Baines, a resident of Georgia and former resident of California, has applied for executive clemency.

On June 26, 1996, the Superior Court of California, County of Los Angeles, sentenced Mr. Baines to three years of probation and 1 year in jail for second degree robbery. He was 19 years old at the time of his crime.

Mr. Baines has complied with the provisions of California Penal Code sections 4852.01 through 4852.22, which provide a procedure after completion of sentence to seek restoration of civic rights and responsibilities. On July 21, 2022, the Superior Court of California, County of Los Angeles, granted Mr. Baines a Certificate of Rehabilitation on evidence that he has been living an upright life. By granting Mr. Baines's petition for a Certificate of Rehabilitation, the court has recommended that Mr. Baines be granted a full pardon.

This act of clemency for Mr. Baines does not minimize or forgive his conduct or the harm it caused. It does recognize the work he has done since to transform himself, and his service to California and the United States in the Marine Corps.

By the laws of this state it is proper that I, as Governor of the State of California, give testimony that, by completion of his sentence and good conduct in the community, Mr. Baines merits this pardon.

THEREFORE, I, GAVIN NEWSOM, Governor of the State of California, by virtue of the authority vested in me by the Constitution and statutes of the State of California, do hereby grant to Jamar Baines a full and unconditional pardon for the above case.

PARDON

Fabian Rebolledo

Fabian Rebolledo, a resident of California, has applied for executive clemency.

On August 20, 2008, the Superior Court of California, County of Los Angeles sentenced Mr. Rebolledo to 16 months in prison for passing a fictitious check. On June 10, 2015, the court reduced Mr. Rebolledo's felony conviction to a misdemeanor, and on September 13, 2017, vacated the conviction pursuant to Penal Code section 18.5 and imposed a time-served sentence of 364 days in jail.

Mr. Rebolledo submitted a formal application for executive clemency in the form of a gubernatorial pardon. He has provided evidence that he is living an upright life and has demonstrated his fitness for restoration of civic rights and responsibilities. Mr. Rebelledo has also presented evidence that a collateral consequence of his conviction, namely, his impending deportation and permanent separation from his family and removal from his community, further justifies this exercise of executive clemency.

This act of clemency for Mr. Rebolledo does not minimize or forgive his conduct or the harm it caused. It does recognize the work he has done since to transform himself and his service to California and the United States in the Army.

By the laws of this state it is proper that I, as Governor of the State of California, give testimony that, by completion of his sentence and good conduct in the community, Mr. Rebolledo merits this pardon.

THEREFORE, I, GAVIN NEWSOM, Governor of the State of California, by virtue of the authority vested in me by the Constitution and statutes of the State of California, do hereby grant to Fabian Rebolledo a full and unconditional pardon for the above case.

Andres Rodriguez De Leon

Andres Rodriguez De Leon, a resident of California, has applied for executive clemency.

On July 23, 1963, the Superior Court of California, County of Madera, sentenced 19-year-old Mr. De Leon to two years of probation and 180 days in jail for burglary. On September 7, 2007, the Superior Court of California, County of Madera, sentenced Mr. De Leon to three years in prison for possession of a controlled substance for sale. On December 9, 2022, the court vacated the felony, and Mr. De Leon was sentenced to a time-served probation term for the misdemeanor offense of accessory to a felony. Mr. De Leon has also sustained misdemeanor convictions in Madera County.

Mr. De Leon submitted a formal application for executive clemency in the form of a gubernatorial pardon. He has provided evidence that he is living an upright life and has demonstrated his fitness for restoration of civic rights and responsibilities.

This act of clemency for Mr. De Leon does not minimize or forgive his conduct or the harm it caused. It does recognize the work he has done since to transform himself and his service to California and the United States in the Army and, later, the Army Reserve.

By the laws of this state it is proper that I, as Governor of the State of California, give testimony that, by completion of his sentence and good conduct in the community, Mr. De Leon, merits this pardon.

2. Describe your involvement in the circumstances of the crime(s) for which you are requesting a pardon (attach additional pages if necessary).

My 2007 conviction for possession of drugs for sale is a result of my battle with addiction.

I first came to the U.S. through Hidalgo, Texas with my family on January 28, 1955, when I was about eleven. My father had been sponsored by a farmer and received a green card. Eventually, my dad was able to bring my mom and me to the U.S. legally. Our family rapidly grew, and I gained 10 siblings. We didn't have much money, but I always tried to be a good big brother and help my family in any way I could. My whole life I worked, and as a kid I picked tomatoes in the fields.

I decided to join the Army when I was in my early 20s because I wanted a chance to serve my country. Since we had come to the U.S. my parents had become citizens and I had done all my schooling in the United Sates. California was my home, and I wanted to do my part in the Vietnam War. When I first joined the military, it was a whole new way of life. I was stationed in West Germany, where there was a lot of drug use. I did my best to stay clean, however using drugs was part of the culture. I was having trouble adjusting to Army life, so I started using drugs to cope. At this point my drug use was recreational. I didn't see myself as having any kind of drug problem or addiction because it was part of the culture at the time.

I was honorably discharged from service in 1969. Once I left the military, I felt like I again had to re-adjust to a new life as a civilian. I tried to leave drugs in my past, but I was never successful in completely stopping and continued to use recreationally. Despite this, I did my best to be a good father and a good son. I always supported my family through odd jobs. Once my kids got older, I helped my son Andy Jr., a single dad, raise his two boys. As my parents got older, I did what I could to help them out as well. As her firstborn son, my mother and I always had a close relationship. My mom was a diabetic and I would take her to the doctor and buy her medication.

In the 1990s my mom was diagnosed with a heart condition. My mom and I were so close that this diagnosis really affected me. It was during this time that I became addicted to heroin. I started using as a coping mechanism to numb my pain and to help me deal with my sadness. Before this, I would not have considered myself a drug user but once I

started using heroin, I became a full-blown addict. I hated my addiction and tried to quit many times, but the drugs kept winning. After my third or fourth time trying to quit, I was sober for a little while. However, in the early 2000s my mother passed away and I became very depressed. Her death left me feeling so alone, that I began taking heroin again.

In 2006, I came upon even harder times. The death of my mother a few years earlier had hit me badly, and because I was older, I had a difficult time getting employment. I tried to make ends meet by recycling cans I would find in dumpsters, but I wasn't making enough money to live. To be able to survive, I started selling drugs. It was the stupidest thing I have ever done, and I regret ever getting involved in it. In 2007, after less than a year of selling drugs, I knew I wanted to get sober and began going to a methadone clinic to make a change in my life. But it was too late. My neighbor complained to police that I was selling drugs, and that was that—the police came to my house, found drugs, and arrested me.

I pleaded guilty to Cal. Health & Safety Code § 11351, Possession of Heroin for Sales, after I was arrested. My lawyer advised me to accept the plea, and because I knew I had done something wrong, I agreed. I was ultimately sentenced to three years. During my criminal trial, no one ever said anything about me being deported, or the immigration consequences of my plea. If I had known that I was going to be deported because of this charge, I would have pleaded differently. My entire family and life are in California, I never would have risked that. I was sentenced to three years and served eleven months before being handed over to immigration.

C. PARDON REQUEST

1. Explain why you want a pardon (attach additional pages if necessary).

A pardon would make me eligible to come back to the United States legally and would allow me to live out my last years with my family. I want to come back to the United States because it is my home. I am 76 years old and I don't have very much time left on this earth. I want to die surrounded by the people I love and who love me. All of my family members are U.S. citizens, and it's painful to be separated from them. When I do die, I don't want to be buried in Mexico. I want to be buried with my friends who died in the Vietnam War, in a place where my family can visit me.

I have a lot of health issues. I suffer from hearing loss, which I believe is related to an injury I suffered in the Army. I am currently trying to get hearing aids, but it is hard to get any kind of medical help as a veteran in Tijuana. I have type 2 diabetes and I have to buy my own medication, even though the only money I get is from my veteran's pension. If I was back in the U.S., I could get the same medicine for free from the Veterans Administration. My vision is starting to fail me. I need glasses, but I can't afford to get any right now without financial help. I also have a bad knee, making getting around on my own harder and harder. I need to be around my sisters and my son. I know they could help take care of me.

I would like to meet all my grandchildren before I pass away. My son is a single dad. Before I was arrested, I was helping him with his kids. I want to set an example for my grandkids. I want to give them advice on how to stay out of trouble and have a good life. My father is currently in his late 90s. He does not have much time left, and he wants to see me before he dies. I am his oldest son and I would like to be there for him as we both reach the end of our lives.

2. Explain why you think you should be <u>granted</u> a pardon (attach additional pages if necessary).

I deserve to be granted a pardon as a proud U.S. Army veteran who served during wartime and whose entire immediate family are U.S. citizens and live in the U.S.

After my arrest in 2007, I decided to get sober and focus on my recovery. I needed to be healthier for myself and my family. However, after my time in prison was up, I was taken directly into immigration custody. While I was in immigration detention, I saw an immigration judge a few times. The judge told me to hire a lawyer, but I had no money. My family tried to see if they could find an attorney, but they weren't able to find the funds. I lost my case and was deported to Mexico.

When I was first deported to Tijuana, I had a real hard time. I had issues with the language and that made everything difficult. I was depressed because I did not have any family or friends in Mexico. I was lonely. My family is all in California, including my siblings, my children, and all my grandchildren. Despite having a hard time, I stayed sober. I go to church every Sunday and have friends who have helped me stay drug-free. I have been sober for over ten years. I now see that drugs are bad and that they destroy people's lives. I am grateful that I have been substance-free now for about thirteen years. My biggest regret is not being able to spend the time I have left with my family, I want the chance to make up for lost time.

After I enlisted in the Army, all my brothers enlisted after me. Both of my sons eventually enlisted when they were old enough. My family tells me they joined because they wanted to follow in my footsteps. I am happy that I helped inspire so many of my family to enlist in the military. I am proud of this legacy and of being part of a military family. I want to enjoy this family first-hand back home in California.

I know that I did wrong in my life, and I deeply regret my drug use. Drugs caused me nothing but problems. Still, I believe I deserve a second chance because I risked my life for Uncle Sam. I just want to come home to see my family before I die, and I feel as if I have earned that right as a veteran. I am a Christian and I believe that Jesus died for my sins. I have done, and will continue to do, everything I can to live out the rest of my life as a Christian. Please grant my pardon application so I can show my family how far I've come and live out my last years surrounded by those I love.

Ernest Sari, a resident of California, has applied for executive clemency.

On January 24, 2002, the Superior Court of California, County of Los Angeles, sentenced Mr. Sari to three years in prison for possession of a controlled substance while armed with a firearm.

Mr. Sari has complied with the provisions of California Penal Code sections 4852.01 through 4852.22, which provide a procedure after completion of sentence to seek restoration of civic rights and responsibilities. On January 30, 2018, the Superior Court of California, County of Los Angeles, granted Mr. Sari a Certificate of Rehabilitation on evidence that he has been living an upright life. By granting Mr. Sari's petition for a Certificate of Rehabilitation, the court has recommended that Mr. Sari be granted a full pardon.

This act of clemency for Mr. Sari does not minimize or forgive his conduct or the harm it caused. It does recognize the work he has done since to transform himself, and his service to California and the United States in the Army National Guard.

By the laws of this state it is proper that I, as Governor of the State of California, give testimony that, by completion of his sentence and good conduct in the community, Mr. Sari merits this pardon.

THEREFORE, I, GAVIN NEWSOM, Governor of the State of California, by virtue of the authority vested in me by the Constitution and statutes of the State of California, do hereby grant to Ernest Sari a full and unconditional pardon for the above case.

REPRIEVE OF SENTENCE

Andre Bragg

In 1992, Andre Bragg drove as his crime partner shot at another car, killing one victim and injuring a second. On April 21, 1993, the Superior Court of California, County of San Joaquin, sentenced Mr. Bragg to 15 years to life for second degree murder, plus an additional seven-year term for attempted murder, for a total prison term of 22 years to life.

On January 28, 2021, the Superior Court vacated and dismissed Mr. Bragg's murder conviction pursuant to Penal Code section 1170.95, and imposed a sentence of seven years for attempted murder. Mr. Bragg, who had served nearly 29 years in the California Department of Corrections and Rehabilitation (CDCR), was released from prison and placed under the supervision of CDCR's Division of Adult Parole Operations. Mr. Bragg successfully completed his term of supervision and was discharged from parole on February 7, 2022. For the last year, Mr. Bragg has lived at liberty in the community, not under sentence or supervision.

The San Joaquin County District Attorney's Office appealed the Superior Court's resentencing order. On June 17, 2022, the California Court of Appeal, Third Appellate District, reversed the Superior Court's order and remanded the case for reinstatement of the original judgment and sentence. Mr. Bragg appeared in the Superior Court on January 3, 2023 and his original conviction and sentence were reinstated.

I have carefully considered and weighed the unique procedural factors in this case. I have concluded that, once Mr. Bragg is returned to the authority of CDCR, his transfer to an appropriate alternative community placement to serve the remainder of his re-instated sentence is consistent with public safety. It is also in the interest of the State of California, which has incarcerated Mr. Bragg for nearly 29 years, and then supervised him on parole, which he successfully completed. CDCR has fulfilled its responsibility to fully and safely reintegrate Mr. Bragg into his community.

This temporary reprieve does not minimize or forgive Mr. Bragg's past misconduct and the great harm it caused, nor alter his conviction or sentence.

THEREFORE, I, GAVIN NEWSOM, Governor of the State of California, by virtue of the authority vested in me by the Constitution and statutes of the State of California, do hereby grant a reprieve to Andre Bragg to make him immediately eligible to be transferred to an alternative custody placement in the community approved by the Division of Adult Parole Operations. This reprieve allowing Mr. Bragg to continue serving his sentence in the community under the supervision of CDCR is temporary and may be nullified at any time for any reason, resulting in Mr. Bragg's immediate return to CDCR custody.

REPRIEVE OF SENTENCE

Jofama Coleman

On August 18, 2007, the Superior Court of California, County of Los Angeles, sentenced Mr. Coleman to 25 years to life for murder. Mr. Coleman has served 19 years in prison.

On July 6, 2023, the Board of Parole Hearings (Board) conducted a parole hearing and found Mr. Coleman suitable for immediate release on parole. On December 1, 2023, I referred Mr. Coleman's parole case back to the Board for further review. On December 19, 2023, the Board reviewed Mr. Coleman's case en banc, determined that he is suitable for release on parole, and voted to reinstate his parole grant.

Mr. Coleman's controlling release date is July 14, 2024. I have carefully considered the relevant case factors, including that Mr. Coleman, like his crime partner, will have his conviction vacated by the Superior Court of California. County of Los Angeles, based on a judicial finding of factual innocence. I have concluded that Mr. Coleman's transfer to an appropriate alternative placement in the community to continue serving the remaining six months of his sentence is consistent with public safety and in the interests of justice.

This reprieve of sentence does not minimize or forgive Mr. Coleman's past conduct or any harm it caused.

THEREFORE, I, GAVIN NEWSOM, Governor of the State of California, by virtue of the authority vested in me by the Constitution and statutes of the State of California, do hereby grant a reprieve to Jofama Coleman to make him immediately eligible to be transferred to an alternative custody placement in the community approved by the Division of Adult Parole Operations. This reprieve allowing Mr. Coleman to continue serving his sentence in the community under the supervision of the California Department of Corrections and Rehabilitation (CDCR) is temporary and may be nullified at any time for any reason, resulting in Mr. Coleman's immediate return to CDCR custody.

MEDICAL REPRIEVE OF SENTENCE

Alan Mabrey

In 2009, Alan Mabrey drove while under the influence of alcohol and struck a pedestrian, Emily Dowdy, killing her. On December 15, 2009, the Superior Court of California, County of San Diego, sentenced Mr. Mabrey to 15 years to life for gross vehicular manslaughter while intoxicated plus five years of sentence enhancements, a total prison term of 20 years to life.

Mr. Mabrey is now 59 years old and has been incarcerated for nearly 15 years. On October 25, 2022, the Board of Parole Hearings ("Board") conducted a parole hearing and found Mr. Mabrey suitable for release on parole. In February 2023, I referred the case back to the Board for *en banc* review. I asked the full Board to determine whether Mr. Mabrey could be safely released. On March 21, 2023, the full Board affirmed Mr. Mabrey's parole grant. Mr. Mabrey has a future release date in April 2025.

California Department of Corrections and Rehabilitation (CDCR) medical staff have deemed Mr. Mabrey a high medical risk based on his chronic, serious medical conditions.

I have carefully considered and weighed the evidence of Mr. Mabrey's medical condition, the unique procedural history in this case, Mr. Mabrey's 15year record of sobriety, and other relevant case factors. I have concluded that Mr. Mabrey's temporary transfer to an appropriate alternative placement in the community to continue serving his sentence and receiving medical care is consistent with public safety and public health.

This temporary reprieve does not minimize or forgive Mr. Mabrey's past misconduct and the great harm it has caused, nor does it alter his conviction or sentence.

On July 26, 2000, the Superior Court of California, County of Sacramento, sentenced Ms. Perez to 25 years to life for assault resulting in the death of a child under eight years of age. Ms. Perez has served 23 years and seven months.

On March 15, 2023, the Board of Parole Hearings ("Board") conducted a parole hearing and found Ms. Perez suitable for immediate release on parole. On June 30, 2023, I completed review of the case and agreed with the Board's determination that she is currently suitable for release on parole.

Ms. Perez's controlling release date is January 6, 2024. I have carefully considered the relevant case factors and I have concluded that Ms. Perez's transfer to an appropriate alternative placement in the community to continue serving the remaining four months of her sentence is consistent with public safety and in the interests of justice. This reprieve of sentence does not minimize or forgive Ms. Perez's past conduct or the harm it caused.

THEREFORE, I, GAVIN NEWSOM, Governor of the State of California, by virtue of the authority vested in me by the Constitution and statutes of the State of California, do hereby grant a reprieve to Alicia Perez to make her immediately eligible to be transferred to an alternative custody placement in the community approved by the Division of Adult Parole Operations. This reprieve allowing Ms. Perez to continue serving her sentence in the community under the supervision of the California Department of Corrections and Rehabilitation (CDCR) is temporary and may be nullified at any time for any reason, resulting in Ms. Perez's immediate return to CDCR custody.
